Replacing Fossil Fuel with Renewable Energy Sources	Sonen has multiple exposures to renewable energy generation across our public and private investment strat- egies including solar, wind and technologies that transition the energy grid to accommodate the expansion of renewable energy. Sonen's strategies are not exposed to coal exploration or development, nor exploration or production of nat- ural gas or oil. Sonen's equity portfolio avoids both the largest emitters as well as maintains a carbon emissions profile that is more than 9X lower than the MSCI ACWI. ¹
Wealth Inequality & Protecting Vulnerable Populations	 The poor and vulnerable are disproportionately exposed to climate change, resource scarcity and pollution. Sonen considers socially equitable solutions in a number of ways in its strategies, including those in our Global Fixed Income strategy, such as: Investments with community banks and community development finance institutions. Exposure to World Bank Green Bonds, which aim to improve climate resiliency amongst vulnerable populations globally. Investments in municipal bonds that provide critical goods and services such as pollution mitigation projects that disproportionately affect disadvantaged populations.
